**TENDER NOTICE INVITING QUOTATIONS FOR ONLINE ADMISSION MANAGEMENT & SOFTWARE SUPPORT SERVICES AT KABI JAGADRAM ROY GOVT. GENERAL DEGREE COLLEGE, MEJIA – 722 143 FOR THE FY 2018 – 2019.**

Sealed quotations are invited from reputed firms/suppliers for supply of the following categories of items and services:

1. Online admission management (web-based) services, including payment interface and online counselling
2. Development and deployment of software and support services for management of online admission
3. Maintenance of integrated web-services with separate domain for online admission management

Quotations may be submitted for individual items mentioned above or for package covering all of the items mentioned above. The following must be adhered to while submission of quotations:

- (a) Quotations must be submitted in self-made format in original in official pad of the company along with detailed specifications of items and all relevant information, including terms and conditions (if any) and mentioning all levies, installation charges, service charges, and taxes, etc., and any other charges thereon.
- (b) Quotations and all bills must be addressed to “*The Officer-in-Charge, Kabi Jagadram Roy Government General Degree College, Mejia – 722 143.*”
- (c) All legal documents including necessary governmental/municipal approval, permissions and certificates must be enclosed.
- (d) Quotation documents are non-returnable.
- (e) As per govt. rules, income tax at the following rates shall be deducted at source for services rendered:
