NOTICE OF EXTENSION OF DATE OF SUBMISSION OF QUOTATIONS FOR TENDER NOTICE INVITING
QUOTATIONS FOR ENGAGEMENT OF PRIVATE SECURITY PERSONNEL AT
KABI JAGADRAM ROY GOVT. GENERAL DEGREE COLLEGE, MEJIA – 722 143.

In view of the non-submission of requisite number (at least four) of quotations for *Engagement of Private Security Personnel* in response to *Tender Notice No.: 080-B/0518/Tender-Notice/2018-2019/Pvt.-Security, dated: 22nd. May 2018*, of this college, and the above fact being verified upon the opening of the sealed Tender Box in the presence of proprietors of companies/firms or their authorised representative who had already submitted quotations, the last date of submission of tenders for the aforementioned service is hereby extended for a period of 10 (ten) days (till 13:00 hrs. of 23rd. June 2018), and opening of quotations shall take place on Monday 25th. June 2018, in the chamber of the undersigned at 13:00 hrs.

It is further clarified that quotation documents/technical bids submitted by the bidders/companies/firms were not opened on the previously scheduled date of opening of the Tender Box, i.e. 13th. June 2018, and shall be opened on the re-scheduled date of opening of quotations, i.e. Friday 22nd. June 2018 at 12:00 noon.

Other terms of conditions of the Tender Notice shall remain the same.

This is in concurrence with Memo No. 3661-F(Y) dated 7th. June 2018 of the Finance Department (Audit Branch) of the Government of West Bengal.

The last date for submission of quotations to the college office shall be Saturday 23rd. June 2018 up to 13:00 hrs., and quotations shall be opened on Monday 25th. June 2018 at 13:00 hrs.

The Principal/Officer-in-Charge, Kabi Jagadram Roy Government General Degree College, reserves the right to accept or reject any or all of the quotations without assigning any reasons thereof.

MEMORANDUM

Sub: Revised norms for extension of dates for getting more bids when the nos. of bids received is less than three or insufficient


As per Para-I of Finance Department's Memo. No. 925-F(Y) dated 14.02.2017, provisions for extension of last date of submission of bids, when the nos. of bidders during tender/re-tender is less than three, were introduced. In terms of the said provisions the last date of submission of bids can be extended only if the notice for extension is issued within the life of the tender period.

2. However, as per the existing provisions available in the **e-Procurement (e-Tender) Portal** (wbtenders.gov.in) of the State Government, the number of bids received can be known only after the expiry of bid submission period. In the above circumstances, Para-I of Finance Department's Memo. No. 925-F(Y) dated 14.02.2017 is **amended** as follows:

- i. The tender process is to be initiated well in advance keeping in mind that there may be a situation for extension of last date and/or re-tender.
- ii. **The last date of submission may be extended (for both e-tender and offline tender processes) if notice of extension is issued before opening of the technical bids.** However, such extension may generally be made for at least 5 days which would be counted from the date of publication of the corrigendum notice for such extension in at least one widely circulated newspaper.
- iii. After opening of the technical bids, the date cannot be extended, however re-tender may be invited.
- iv. Extension of dates cannot be treated as 2nd or subsequent call.

3. All other provisions contained in the FD's Memo. No. 925-F(Y), dt.14.02.2017 shall continue to apply.

4. This Order will take immediate effect.
